

Reliable Silver Corporation's Privacy Policy

Reliable Silver Corporation ("RSC") respects your right to privacy and is committed to protecting your personal information. To protect your personal information from unauthorized access and use, we use security measures that comply with federal law, including Connecticut's Data Privacy Act, ("CTDPA"). These measures include robust computer cybersecurity safeguards, secured files, and buildings. We restrict access to employees, representatives, agents, or selected third parties who have been trained to handle such nonpublic personal information and we are committed to adhering to responsible, ethical business practices.

The policy herein describes the procedures that we have established to safeguard the handling of your personal information. It describes what information we collect, how we collect it, and how we use it. Furthermore, it affords you the opportunity to correct, change, and/or control your information.

WHAT INFORMATION WE COLLECT AND HOW WE COLLECT IT

"Personal data" is any information that can be linked directly or indirectly to an identifiable individual, excluding publicly available information. Some examples of personal data include: a home address, a driver's license or state identification number, passport information, a financial account number, online identifier such as login credentials, and payment card information. It can also include more specifics, such as the physical, genetic, cultural, and social attributes of an individual

1. Information that you provide:

Interacting with our website may provide us with personal data and the amount and type of information that you provide will depend on the nature of the interaction.

We may also collect lists containing personal contact information from Industry tradeshow and for use as permitted by the supplying organization. These lists may be uploaded into our prospective customers (Prospects) database or mailing lists software and kept indefinitely.

For example, suppose you wish to:

- Request a quote
- Download our Terms and Conditions, Safety Data Sheets, or a multitude of Policy Statements and Certifications.

We may in turn ask you to provide the following information:

- Company name and address
- Contact Name
- Telephone and fax numbers
- Email address

You may at any time withdraw your consent to our collection, use, or disclosure of your personal information, on reasonable notice, subject to certain legal or contractual restrictions that might apply in a given situation. We will inform you of the implications of withdrawing your consent to such collection, use, and disclosure.

If for some reason we cannot fully comply with your withdrawal request, we will notify you. For example:

- We are required to collect and keep certain personal information about customers and their related business practices. Prior to preparing a quote or processing an order, we will need to collect at least minimal information from customers to satisfy our Anti-Money Laundering policy and Conflict Free Sourcing policies, both of which appear on our website.
- We will retain these records indefinitely (including personal information) or for a minimum of 10 years from the customer's last order, or as otherwise required by law.
- Once a customer has transacted an order, we will be unable to honor requests to delete personal information for beneficial owners or key persons. However, your information is maintained by us and will not be disseminated outside the company unless required to by law or court order.
 - Examples of such information may include:
 - Employer Identification Number
 - Driver's License Number
 - Beneficial Ownership information
 - Bank and Credit References

2. Information that we receive from your passive use of our website (Cookie Policy)

The vast majority of companies collect information about your use of our website through tracking technology such as "Cookies" to analyze their website traffic and enhance your user experience.

"Cookies" are small text files that are placed on your computer by websites that you visit. Cookies do not collect or keep your name or personal information other than a numeric identifier. They are widely used to make websites work, or work more efficiently, as well as to provide information to the owners of the websites that you visit.

Our rationale for adopting Cookies is not unique to operation of a commercial website and is necessary for our legitimate business purposes:

- To compile anonymous report data on website traffic, including:
 - Pages visited
 - Source origin of inquiries
 - Number of visitors and recurrences

- Duration of stay
- What search engine was employed
- What key words were employed in search

RSC's USE AND RETENTION OF YOUR INFORMATION

By using our site, you consent to our web site privacy policy.

We may use your personal information only as reasonably long to serve our business purposes for which it was collected including:

- To promote our company, products, and services.
- To maintain, administer, and improve our website.
- To assist with our regulatory compliance.

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential, or to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.

CHILDREN'S PRIVACY

We are in compliance with the requirements of COPPA, (Childrens Online Privacy Protection Act). As such, we do not collect information from anyone under 13 years of age. Our website, products, and services are directed to individuals 18 years and older, whose business-to-business or business-to-academia & research interests align with ours.

CALIFORNIA ONLINE PRIVACY PROTECTION ACT COMPLIANCE

We have taken the necessary precautions to be in compliance with CAOPPA,(California Online Privacy Protection Act), and therefore, we will not distribute your personal information to outside parties without your consent.

YOUR RIGHTS REGARDING YOUR PERSONAL DATA

- At any time, once you have sufficiently verified your identity, you amend the accuracy and completeness of your personal information.
- You have the right to request that we permanently delete your personal information when:
 - We no longer need your data for the purposes for which it was collected.

- You withdraw your consent, and there is no other legal ground for us to continue processing your information.
- Erasure is required by law.
